Entry fees for our qualifications have increased so they better reflect the true costs of delivering these qualifications. This approach means we can continue to:

- offer the widest range of qualifications
- invest in our qualifications
- improve our support services.

Entry fees for international schools

The entry fee for overseas schools entering for AQA qualifications is different to the fee for domestic customers to cover both the rising costs of delivery and the additional security needed when exams are sat internationally. These prices do not apply to any schools in British Overseas Territories.

Where the money goes

As an independent education charity, we work hard to manage our costs. We reinvest our income back into education. This means we're able to continuously improve our qualifications and assessments and the support we provide, and means we're able to continue to offer qualifications with low numbers of entries.

It also funds other educational services, such as assessment research that benefits the whole education system. - Data Insights – which has replaced our Enhanced Results Analysis platform
- dedicated support and advice on non-exam assessment (NEA).

We reinvest entry fees into creating and delivering high quality qualifications and assessments and offering as wide a choice of subjects as possible – along with comprehensive support and training packages for teachers. It also means we're able to subsidise some of our qualifications.

Entry details

Dates and explanation of charges

Basedata

Basedata is specification, fees and timetable information in the inter-board common format. It is designed to be imported into school or college administration software. Please see aqa.org.uk/basedata

Entry deadline

The final date for entries to be received by us before additional charges are applied.

Entry fee

The fee charged for each student entered for a unit or qualification.

Late entry fee

Charged for each entry for a **new** student received after the entries deadline for each exam series. This fee is 100 % of the original entry fee and is in addition to the entry fee.

Very late entry fee

Charged for each very late entry for a **new** student received from the date specified for each exam series (see table of key dates on page 6). This fee is 150 % of the original entry fee and in addition to the entry fee.

Amendment fee

Charged for each amendment to entries for an **existing** student made from the date specified for each exam series (see table of key dates on page 6). This fee is 100 % of the original entry fee and is in addition to the entry fee for any new entry.

Withdrawn entries

We will offer a credit note for each entry withdrawn by schools/colleges before the date specified for each exam series (see table of key dates on page 6).

Late, very late and amendment fees are not refunded. No credit notes are provided for entries withdrawn after these dates (except on medical grounds, where partial refunds will be considered) or where students are simply absent from the exam. Any request for a partial refund of fees must be accompanied by satisfactory supporting medical evidence. Fees paid cannot be carried forward from one exam or series to another.

Late awards for modular qualifications (aggregations)

Subject award entries will be accepted without additional fees during the four week period immediately following the publication of results until the closing date for review of results.

Very late awards

After the closing date for review of results requests for an award (aggregation) in that series or any previous series will incur an additional fee of £48.00 per student per subject award to be aggregated.

Total Qualification Cost (modular qualifications)

The total amount of all fees for each unit necessary to aggregate a subject award for a modular qualification. We do not charge a fee for aggregation, i.e. the entry code you must submit for bringing unit results together for a subject award. The fee does not include re-sits of units.
